This conservation measure is adopted in accordance with Article IX of the Convention:

Directed fishing on taxa in areas specified in Annex 32-02/A is prohibited, subject to the conditions listed in that annex.

Prohibition of directed fishing, subject to conditions as indicated:

- <sup>1</sup> The prohibition shall not apply to the taking of specified taxa for the purpose of scientific research in accordance with Conservation Measure 24-01.
  - <sup>2</sup> The prohibition shall apply until at least such time that a survey of stock biomass is carried out in the specified area, its results reported to, and analysed by, the Working Group on Fish Stock Assessment and a decision that the area be reopened to directed fishing for that taxon is made by the Commission based on the advice of the Scientific Committee.
  - <sup>3</sup> The prohibition shall apply until a decision that the area be reopened to directed fishing for that taxon is made by the Commission based on the advice of the Scientific Committee.
  - <sup>4</sup> By-catches of *Notothenia rossii* in fisheries directed to other taxa shall be kept to the level allowing the optimum recruitment to the stock.
  - <sup>5</sup> Except for waters adjacent to the Prince Edward Islands
  - <sup>6</sup> Except for waters adjacent to the Kerguelen and Crozet Islands
- No prohibition of directed fishing
